
### **Public Hearing** *for* **U.S. Route 45** from IL 132 to IL 173 and the Millburn Bypass

# U.S. 45 Project Overview & Environmental Assessment


The Lake County Division of Transportation (LCDOT) in coordination with the Illinois Department of Transportation (IDOT) initiated a Phase I Engineering and Environmental Study to evaluate likely long term improvement needs for U.S. Route 45 from IL 132 to IL 173 with additional focus on the Grass Lake Road and Millburn Road intersections in the vicinity of the Millburn Historic District. U.S. Route 45 serves as a vital north-south transportation link from the Wisconsin border south to Chicago's northern suburbs. The offset intersections within the Millburn Historic District are two of Lake County's worst congestion trouble spots, hence the nickname "the Millburn Strangler."

These identified needs coupled with engineering, environmental studies, and community input, led to the development of 18 alternatives to address existing and future capacity, mobility, safety and operational deficiencies. Subsequently, a preferred alternative was selected that best addresses the defined needs and would provide two lanes in each direction from IL 132 to IL 173 with turning lanes at specific intersections.

Within the vicinity of the Millburn Historic District, a west bypass was selected that accommodates a bike path on the west side and sidewalks on the east side. A raised center median is proposed along U.S. 45 to enhance safety, provide water quality benefits, and provide green space for potential plantings. In addition, Grass Lake Road will be re-aligned to the south thus eliminating the existing offset intersection through the Historic District.

The selected alternative has the best transportation performance, best accommodates existing and future travel patterns, avoids the Millburn Historic District, is the preferred roadway design, is compatible with Lake County Forest Preserve District regional trail objectives, and is compatible with longstanding transportation and land use plans. The Environmental Assessment summarizing this analysis is available for review and comments at this public hearing and on the project website beginning March 6 or earlier.

### Purpose and Need

The purpose and need for this project is to reduce congestion, improve safety, and correct design deficiencies for U.S. Route 45 from IL Route 132 to IL Route 173



Reduce Congestion:

- 30% population and employment growth by 2040
- 100% traffic growth by 2040
- 300% increase in traffic delay by 2040



Improve Safety:

- 562 crashes during 5 year study period
- 43% rear-end and turning crashes due to congestion
- 368 crashes at signalized intersections



- Correct Design Deficiencies:
- Adverse offset of U.S. 45 intersections within the Historic District
- Limited sight distance at U.S. 45 and Grass Lake Road intersection
- Restricted right-of-way through Historic District

## Commitment to the Environment & Sustainable Solutions:

In accordance with best management practices for drainage, grassed barrier curb medians and three detention ponds are proposed within the Millburn Bypass area to improve water quality from roadway runoff. At locations where traffic noise will increase and at other locations, landscaping features such as vegetation are proposed to provide new or enhanced visual screening between the roadway and residences.


Other possible design enhancements include:

- Median landscaping/aesthetics
- Pedestrian and bicycle accommodations & connections
- Roadway details (turnarounds & u-turn locations, east Haven Lane cul-de-sac)
- Streetscape features (community entryways, etc...)


